

**GEORGE WALLACE RIDER**

THIS RIDER IS ATTACHED TO AND MADE A PART OF THE CONTRACT DATED \_\_\_\_\_ between Crazy World Inc. FSO **GEORGE WALLACE** (hereinafter referred to as "Artists" / "Producer") and \_\_\_\_\_ (hereinafter referred to as "Purchaser") for the performance of said Artist/Producer on \_\_\_\_\_.

All terms and provisions hereinafter and hereinbefore set forth part of one and the same contract.

1. The ARTIST shall receive 100% Sole Star billing in any and all advertising and publicity pertaining to the engagement hereunder, unless otherwise stated and approved in writing.
2. All payments provided hereunder shall be made payable by money order, certified or cashier's check payable to: CRAZY WORLD, INC.
3. Artist's obligations herein are subject to detention or prevention by sickness, inability to perform, accident, transportation, acts of God, riots, strikes, labor disputes, epidemics, or any act or order of public authority or any cause similar or dissimilar beyond ARTIST'S control.
4. No part of the performance shall be taped, recorded or filmed without prior, written consent of ARTIST.
5. It is understood and agreed that ARTIST shall have total control over the production, presentation and performance of his segment of the engagement. Due to health concerns, ARTIST respectfully requests NON-SMOKING ONLY."
6. PURCHASER agrees to furnish at their sole cost and expenses the following items:
  - a) A first class, high quality sound system with one (1) cordless handheld microphone (and a backup mic) and (1) straight MC stand and a stool on stage with two bottles of water on the stool.
  - b) High quality, professional stage lighting, including one (1) Carbon-arc type follow spot with operator.
  - c) Fruit juices, Orange Juice, Snapple fruit punch, spring water, hot tea with lemon and a Gillette fusion 5 razor.
  - a) PURCHASER agrees that no food or beverage be served during or just prior to performance. If food is served, all dishes will be collected prior to performance.
  - b) A high quality audio player for use with the sound system play and pre-and-post shows music. Video with projector screen for Video content. The house soundman will run this machine.
  - c) ARTIST requires an opening for all shows. Said act should be submitted two (2) weeks prior to performance for ARTIST'S approval. Specific requirements for opener. Clean (not blue), straight stand-up comedians should be used. There will be no more than one (1) opening act in addition to the MC.
7. PURCHASER agrees that ARTIST will have the right to cancel this agreement without liability upon notice to PURCHASER no later than thirty (30) days prior to the first day of

engagement, in the event that Artist secures a commitment for theatrical motion picture or television appearance.

8. PURCHASER agrees to supply a fully refundable first class round trip Delta Airline ticket for ARTIST and a single coach ticket ARTIST representative.
9. PURCHASER agrees to supply ARTIST ten (10) complimentary show tickets for artists guests in the VIP SECTION or the very first row behind the VIP section.
10. PURCHASER agrees to supply a HOTEL SUITE with a separate bedroom for ARTIST and a single room for ARTIST representatives.
11. PURCHASER shall provide a professional driver and large, clean, pet-free, SUV (ie Navigator or Cadillac) for all ground transportation (pick-up at airport, to and from hotel and place of engagement and return to airport).
12. PURCHASER will not commit ARTIST to any personal appearances or other promoters without the prior, written consent of ARTIST or ARTIST'S REPRESENTATIVE.
13. PURCHASER will provide ARTIST with an adequate dressing room with a door that can be locked and secured while ARTIST is performing, during any intermissions and upon completion of program.
14. PURCHASER will provide ARTIST with a \$150 per diem meal allowance.
15. PURCHASER will be solely responsible for the security of items left in the dressing room area while ARTIST is performing, during any intermission and upon completion of program.
16. PURCHASER shall arrange seating in such a manner that front row seating shall begin no more than four (4') feet from the front of the stage.

IT IS UNDERSTOOD AND AGREED THAT PURCHASER WILL NOT ADD TO, DELETE FROM OR MAKE ALTERATIONS IN THE CONTRACT OR CONTRACT RIDER, WITHOUT PRIOR WRITTEN CONSENT OF ARTIST. THIS RIDER, TOGETHER WITH CONTRACT ATTACHED, CONSTITUTES THE ENTIRE AGREEMENT BETWEEN PARTIES.
